Officials Celebrate Completion of Charleston County's Consolidated 9-1-1 Center and Emergency Operations Center

On Thursday, Jan. 24, officials from multiple jurisdictions in Charleston County gathered for a ribbon cutting ceremony celebrating the grand opening of Charleston County's Consolidated 9-1-1 Center and Emergency Operations Center. The 38,000-square-foot structure has a dual purpose in that it houses two of Charleston County Government's major departments: the Consolidated 9-1-1 Center and Emergency Management Department. In essence, it enables the full consolidation of 9-1-1 and emergency dispatch operations in Charleston County and serves as the new location for the Emergency Operations Center.

FACTS ABOUT THE NEW CENTER:

- Construction started in June of 2011 and finished on schedule in November 2012.
- Location: 8500 Palmetto Commerce Parkway, North Charleston, S.C.
- Size: approximately 38,000 square feet.
- Facility: two-story structure with backup electrical, water and sewer to ensure continuous operation.
- "Green" features: Leadership in Energy and Environmental Design (LEED) silver certification goal, rainwater collection, water efficient landscaping and use of recycled materials. The process to obtain certified is underway and may take up to a year.
- Cost: \$26,780,000 (total project cost including land, design fees, construction, equipment and furnishings).
- Safety: the building is designed to be occupied during disasters, with the ability to withstand winds of 191 mph and resist earthquake forces. The first floor is at 49 feet in elevation, which is outside of the 500 year flood plain.
