Notice is hereby given that the Charleston County Board of Voter Registration and Elections will conduct the Special Election for the City of North Charleston City Council District 3 and District 5 on Tuesday, May 27, 2025. Any person wishing to vote in this election must register no later than Sunday, April 27, 2025. Voter registration by mail forms will be accepted if postmarked by Monday, April 28, 2025.
