

NOTICE OF ELECTION

Candidate Filing

A special candidate filing period for South Carolina State House District 113 in Charleston County will open at 12:00 p.m. on Friday, November 22, 2024 and closes at 12:00 p.m. on Saturday, November 30, 2024. Filing hours are weekdays from 8:30 a.m.- 5:00 p.m. and on Saturday, November 30 from 8:30 a.m.- 12:00 p.m. Filing will be closed on November 28th and 29th. Any candidate seeking a political party's nomination for this office must file during this period with either the county board of voter registration and elections or the State Election Commission. The offices, fees, requirements, and filing locations are listed below.

Filing Form:

The Statement of Intention of Candidacy & Party Pledge (SICPP) form required for filing is available in the "Candidate Information" section of scVOTES.gov and at the county voter registration and elections office.

Filing Fee:

Filing fee checks should be made payable to the appropriate state political party. A candidate seeking the nomination of a party nominating by convention does not pay a filing fee.

State Ethics Filings:

Candidates are required to file a Statement of Economic Interests and a Campaign Disclosure online with the State Ethics Commission at <http://ethics.sc.gov>. Failure to file these documents may result in a candidate fine but will not disqualify a candidate from the election. Contact the State Ethics Commission for more information.

Notice of Primary:

If at the close of filing a party primary is necessary to determine the party nominee (multiple candidates file for one party's nomination), a primary will be held on Tuesday, January 21, 2025. Any necessary runoffs will be held on Tuesday, February 4, 2025. Any person wishing to vote in these primaries and runoffs must be registered by Sunday, December 22, 2024. Voter registration by mail applications will be accepted if postmarked by Monday, December 23, 2024.

Early Voting

Early voting will begin on Monday, January 06, 2025 and end on Friday, January 17, 2025. Early voting centers, listed below, will be open from 8:30 a.m. until 5:00 p.m., Monday through Friday (closed Saturday and Sunday).

If a runoff election is necessary, then early voting for a runoff election will begin on Wednesday, January 29, 2025 and end on Friday, January 31, 2025. Early voting hours for a runoff election will be 8:30 a.m. until 5:00 p.m.

Absentee Ballot Examination

The examination of the absentee ballot return envelopes will be examined by the County Board of Voter Registration and Elections in the Charleston County Board of Voter Registration and Elections building located at 4340 Corporate Rd., North Charleston, SC 29405 at 7:00 a.m. on Tuesday, January 21, 2025. If a runoff is necessary, the absentee ballots from that election will be examined at 9:00 a.m. the day before the election.

Provisional Ballot Hearing

A hearing will be held to determine the validity of all provisional ballots cast in this election by the County Board of Canvassers at 10:00 a.m. on Thursday, January 23, 2025. This hearing will take place at the Charleston County Board of Voter Registration and Elections office 4340 Corporate Rd, North Charleston, SC 29405.

If a runoff election is necessary, then a hearing will be held to determine the validity of all provisional ballots cast in the runoff election by the County Board of Canvassers at 10:00 a.m. on Thursday, February 06, 2025. This hearing will also take place at The Charleston County Board of Voter Registration and Elections office on 4340 Corporate Rd, North Charleston, SC 29405.

Election Day

Polling locations will be open from 7:00 a.m. until 7:00 p.m. on Election Day. Always check your polling place at scVOTES.gov prior to the election.
